

Affiliate Program

Article 1

CompeGPS launches affiliate system and is looking for websites or blogs which could relay information about the various products of its catalogue.

The affiliation is a relationship between an advertiser and distributors (affiliates, webmasters) based on performance.

To simplify things, an advertiser proposes to his affiliated some advertising banners so that they broadcast them on their website. The remuneration of members is (usually) not based on clicks, or number of displays, but on sales generated through their website. Each sale generated on the advertiser's site by a client from the site resulted in the payment of a commission to the webmaster of that site.

The more you put forward our products, the more people buy through your site and more money you earn.

Article 2

The type of compensation we have chosen is the CPA (Cost Per Action). The CPA is the most common form of affiliation. Each buying act is paid by a commission according to a commission on the general basket. Every 3 months, each member will receive a receipt on the commission on sales he generated.

To reward the most active sites, we established levels (sales in 3 months):

500 to 1000 €: 6%, from 1000 to 2000 €: 8%, over 2000 €: 10%

The most active site on the quarter will receive **an extra bonus of 100 €**.

Some information about purchases from our Website:

Monthly sales on the compegps.com Website: 13 000 €

Average basket: 60 €

Article 3: Payment

Payment will be made quarterly by bank transfer.

Important: No compensation will be paid if sales are below 500 for the current quarter. The payment will be deferred to next quarter and of course by no means lost. We guarantee the right to cancel at any time the contract with our members after 6 months if sales do not exceed the level of 1000 or for another reason.

Every 3 months we will send you a receipt for your total sales generated and the commission to which you are entitled. You only need to generate an invoice with your data bank on behalf of CompeGPS Team to receive your commission by bank transfer.
